Dear Food Vendor:

The St. Anthony Park Arts Festival is taking applications for food vendors for our 41st annual event, Saturday, June 5, 2010. Last year more than 5,000 people from throughout the area enjoyed this family tradition, which includes an art fair featuring more than 100 artists, 2 music stages, kids' activity tent, family entertainment, sidewalk sales and more.

In order to participate as one of the food vendors, we ask that you complete the enclosed application form and return it along with the \$165 booth fee. Applications are reviewed, approved and space assigned on a first come, first served basis, so return your application as soon as possible. If your application is not accepted, we will promptly return your \$165 booth fee.

Please note: You are responsible for obtaining your own permits and insurance. You will be asked for proof of proper documentation and you will forfeit your booth fee if your paperwork is not in order. Permits are issued through the city of St. Paul, online at www.ci.stpaul.mn.us/. We are unable to refund fees or reschedule the Festival in the event of bad weather. You assume the risk once you pay your fee of \$165. We regret we are unable to provide electrical power in most locations. Vendors may use their own generators. If you use a generator, we require that you muffle the noise.

You will receive written confirmation of your space reservation after we receive your application and fee. We will include in your confirmation your space assignment and other important information. We will make every attempt to comply with requests for specific spaces; however, we cannot guarantee space assignments until we confirm your reservation.

We are working hard to ensure that this year's Festival is a great success for everyone involved. We appreciate your interest in participating with us, and look forward to working with you.
